POR LA PRESENTE SE CERTIFICA que las modificaciones y rectificaciones de la Lista LXXV - Filipinas se han establecido de conformidad con la Decisión antes mencionada.

SCHEDULE LXXV - PHILIPPINES
HEADNOTES TO THE URUGUAY ROUND SCHEDULE OF COMMITMENTS

1. The reductions in tariffs provided for in Section 1A of Part I of this Schedule shall be implemented in accordance with the Customs and Tariff Code of the Philippines which imposes customs duties in round percentage points. Tariff cuts equal to five percentage points or less shall be implemented on 1 July 1999. Tariff cuts equal to 10 percentage points shall be implemented in two equal installments on 1 July 1997 and 1 July 2002. Tariff cuts equal to 15 percentage points and above shall be made in three equal installments as follows: 1 July 1997, 1999 and 2003.
2. The agricultural products in Section 1A of part I of this Schedule in respect of which the provisions of Article 5 of the Agreement on Agriculture may be invoked, if any, are those designated by the symbol "SSG" in Column 4 thereof.
3. The expansion of tariff quotas provided for in Section 1B of Part I of this Schedule, if any, shall be implemented in equal annual installments beginning on 1 July 1995 and ending on 1 July 2004 unless otherwise specified in Column 5 of Section 1B of Part I of this Schedule.
4. Reductions for items contained in HS chapters 50-63 will start on 1 July 1995 from the base rates listed in this schedule. Thereafter, reductions will be implemented in nine equal, annual stages. In cases where reductions will amount to decimal points, the resulting bound rate will be rounded off to the nearest whole number except the final bound rate.
