WHEREAS the CONTRACTING PARTIES to the General Agreement on Tariffs and Trade 1947 adopted, on 26 March 1980, a Decision on Procedures for Modification and Rectification of Schedules of Tariff Concessions (BISD 27S/25);

WHEREAS in accordance with the provisions of the above-mentioned Decision, a draft containing modifications and rectifications to Schedule XX – United States was communicated to all Members of the World Trade Organization in document G/MA/TAR/RS/89 on 23 January 2003;

IT IS HEREBY CERTIFIED that the modifications and rectifications to Schedule XX – United States are established in conformity with the above-mentioned Decision.
