### NEGOCIATIONS AU TITRE DE L'ARTICLE XXVIII:5

#### Liste XIV - Norvège

La Mission permanente de la Norvège a fait parvenir au secrétariat la communication suivante en date du 15 février 1983.

Le gouvernement norvégien a informé les PARTIES CONTRACTANTES qu'il se réservait le droit, conformément aux dispositions du paragraphe 5 de l'article XXVIII de l'Accord général, de modifier sa liste de concessions au cours de la période triennale commençant le 1er janvier 1982 (voir document TAR/43 du 23 décembre 1981).

Par la présente communication, j'ai l'honneur de vous demander de bien vouloir porter à la connaissance des PARTIES CONTRACTANTES que la Norvège a l'intention de modifier des concessions de sa liste, qui relèvent des chapitres 51 à 62 de la NCCD. Les concessions qui seront modifiées ainsi que les<sup>1</sup> statistiques des importations correspondantes sont indiquées en annexe.

Les modifications sont motivées par la nécessité de simplifier le tarif douanier norvégien et plus précisément les sous-positions des positions à quatre chiffres de la NCCD. Il a d'autre part été dûment tenu compte des plans concernant le Système harmonisé afin que ledit système puisse être introduit facilement.

Les modifications suivent dans les grandes lignes les principes énoncés dans le document TAR/W/25/Rev.2. En règle générale, nous offrons les consolidations à un niveau inférieur ou au même niveau que jusqu'à présent. Toutefois, pour des raisons d'ordre technique, nous avons été obligés de relever les taux d'un nombre très limité de sous-positions. Dans ces cas, on a fixé les nouvelles consolidations en appliquant les taux de la ou des sous-positions en vigueur pour l'essentiel des échanges. Certains taux de droits spécifiques ont été convertis en taux de droits ad valorem. Dans le cas de ces sous-positions, nous avons, dans la mesure du possible, donné la valeur des importations pour les années 1979-81. Les modifications comporteront aussi la consolidation de certains taux qui jusqu'à présent n'étaient pas consolidés.

Les modifications, qui touchent 52 positions de la NCCD, se traduisent de la manière suivante:

- pour 73 consolidations, les taux de droits ont été abaissés (valeur totale des importations: 82,9 millions de dollars<sup>1</sup>),
- pour 84 consolidations, les taux de droits sont demeurés inchangés (valeur totale des importations: 267 millions de dollars),
- pour 18 consolidations, les taux de droits ont été relevés (valeur totale des importations: 6,4 millions de dollars).

En résumé, pour une valeur totale des importations de 356,4 millions de dollars, les taux de droits sont demeurés inchangés à raison de 75 pour cent environ, ont été abaissés pour environ 23 pour cent et relevés pour 2 pour cent environ.

S'agissant de 22 consolidations, il a été proposé de convertir des taux de droits spécifiques en taux de droits ad valorem. La valeur totale des importations au titre de ces consolidations s'établissait en 1980 à 9,5 millions de dollars.

La valeur des importations de marchandises visées par les nouvelles consolidations, c'est-à-dire auxquelles ne s'appliquaient pas les consolidations existantes, s'établissait en 1980 à 374,1 millions de dollars.

La Norvège est disposée, sur demande, à engager des négociations ou des consultations conformément aux dispositions de l'article XXVIII applicables en l'espèce.
