CERTIFICATION OF MODIFICATIONS AND RECTIFICATIONS

SCHEDULE CVII – CYPRUS

WHEREAS the CONTRACTING PARTIES to the General Agreement on Tariffs and Trade 1947 (the "GATT") adopted, on 26 March 1980, a Decision on Procedures for Modification and Rectification of Schedules of Tariff Concessions (L/4962)¹;

WHEREAS the Preparatory Committee for the World Trade Organization agreed, on 22 July 1994, that for rectifications of schedules attached to the WTO Agreement and for the establishment of additional concessions under the above-mentioned Decision, the time-limit for approval, during the period up to the entry into force of the WTO Agreement, should be thirty days (PC/M/4);

WHEREAS in accordance with the provisions of the above-mentioned Decision, in light of the time-limit for approval agreed by the Preparatory Committee, a draft containing modifications to Schedule CVII – Cyprus was communicated to all Contracting Parties to the GATT in document G/SP/6 on 21 October 1994;

WHEREAS the entry into force of these modifications of Schedule CVII was dependent upon the entry into force of a Protocol Supplementary to the Marrakesh Protocol to the General Agreement on Tariffs and Trade 1994, which Protocol Supplementary did not come into being;

WHEREAS provision should now be made for the entry into force of these modifications by means of a Certification, as agreed by the Council for Trade in Goods at its meeting on 10 November 2005 (G/C/M/82);

IT IS HEREBY CERTIFIED that the modifications to Schedule CVII – Cyprus are established in conformity with the above-mentioned Decision.

The annexed modifications enter into force as of 20 November 1994, without prejudice to any modifications and rectifications or withdrawal of the Schedule made effective subsequent to that date.

This Certification is deposited with the Director-General of the World Trade Organization, who shall promptly furnish a certified true copy to each Member of the World Trade Organization. It shall be registered in accordance with the provisions of Article 102 of the Charter of the United Nations.

As regards industrial products Cyprus' Tariff is bound at a uniform rate of 40 per cent with the exception of the products mentioned in the attached list.

For products which are bound at 40% there exists an "extra charge" known as Temporary Refugee Levy (TRL) of a maximum of 6 per cent for products originating from Third Countries and of a maximum of 5.7 per cent for products originating from E.U.
