**CERTIFICATION OF MODIFICATIONS AND RECTIFICATIONS**

**SCHEDULE CXXIV – TANZANIA**

WHEREAS the CONTRACTING PARTIES to the General Agreement on Tariffs and Trade 1947 (the "GATT") adopted, on 26 March 1980, a Decision on Procedures for Modification and Rectification of Schedules of Tariff Concessions (L/4962)<sup>1</sup>;

WHEREAS the Preparatory Committee for the World Trade Organization agreed, on 31 May 1994 on a multilateral process to examine and approve schedules of concessions and commitments to the GATT 1994 in respect of certain signatories of the Final Act (PC/M/2);

WHEREAS in accordance with the above-mentioned process, a draft containing modifications to Schedule CXXIV - Tanzania was communicated to all Contracting Parties to the GATT and verified on 4 November 1994:

WHEREAS the entry into force of these modifications was dependent upon the entry into force of a Protocol Supplementary to the Marrakesh Protocol to the General Agreement on Tariffs and Trade 1994, which Protocol Supplementary did not come into being;

WHEREAS provision should now be made for the entry into force of these modifications by means of a Certification, as agreed by the Council for Trade in Goods at its meeting on 10 November 2005 (G/C/M/82);

IT IS HEREBY CERTIFIED that these modifications are deemed established in conformity with the above-mentioned Decision.

The annexed modifications enter into force as of 4 November 1994, without prejudice to any modifications and rectifications made effective subsequent to that date.

This Certification is deposited with the Director-General of the World Trade Organization, who shall promptly furnish a certified true copy to each Member of the World Trade Organization. It shall be registered in accordance with the provisions of Article 102 of the Charter of the United Nations.
