RECTIFICACIONES Y MODIFICACIONES DE LAS LISTAS

LISTA LXXXII - HONG KONG, CHINA

La siguiente comunicación, de fecha 8 de abril de 2020, se distribuye a petición de la delegación de Hong Kong, China.

De conformidad con los procedimientos para la modificación o rectificación de las listas de concesiones arancelarias contenidos en la Decisión de 26 de marzo de 1980 (BISD 27S/25), Hong Kong, China notifica por la presente a los Miembros de la OMC las propuestas de rectificaciones técnicas de la Lista LXXXII que figuran en los anexos¹.

Durante la verificación de los ficheros de transposición al Sistema Armonizado de 2012 (SA 2012) preparados por la Secretaría, Hong Kong, China observó algunas incoherencias entre su lista certificada en la nomenclatura del Sistema Armonizado de 2002 (SA 2002), su lista certificada en la nomenclatura del Sistema Armonizado de 2007 (SA 2007), sus listas arancelarias nacionales y los ficheros de transposición al SA 2012. Las rectificaciones propuestas tienen por objeto corregir los errores detectados o eliminar las incoherencias. Las rectificaciones necesarias conciernen a dos instrumentos jurídicos:

- a) WT/Let/584, en el que figuran los cambios del SA 2002 introducidos en la lista de concesiones de Hong Kong, China anexa al Acuerdo sobre la OMC,
- b) WT/Let/1010, en el que figuran los cambios del SA 2007 introducidos en la lista de concesiones de Hong Kong, China anexa al Acuerdo sobre la OMC.

Las correcciones son de carácter técnico y están destinadas a reflejar de forma más precisa los compromisos contraídos por Hong Kong, China.

En el anexo 1 figuran notas explicativas detalladas y cuadros con las rectificaciones propuestas, y en el anexo 2 se recoge el proyecto de rectificación.¹

Si en el plazo de tres meses contado a partir de la fecha del presente documento no se notifica a la Secretaría ninguna objeción, las rectificaciones y modificaciones de la Lista LXXXII - Hong Kong, China se considerarán aprobadas y serán formalmente certificadas.

ANNEX 1 – EXPLANATORY NOTE

In the course of verifying the HS2012 transposition files prepared by the Secretariat, some inconsistencies between the HS2002 and HS2007 certified schedules of Hong Kong, China; Hong Kong, China's domestic Tariff Schedules; as well as the HS2012 transposition files were identified. Pursuant to the Secretariat's recommendation, Hong Kong, China proposes to rectify the relevant discrepancies as set out below.

(i) WT/Let/584

1. To implement our commitment under Attachment A, Section 2 to the Annex to the Ministerial Declaration on Trade in Information Technology Products ("ITA"; WT/MIN(96)/16), Hong Kong, China has bound "chemical vapor deposition apparatus for semiconductor production" classified as part ("ex") of HS 8419.8900 and such commitment is correctly certified in WT/Let/160¹. Subsequently, Hong Kong, China has bound the whole tariff line HS 8419.8900 (including the non-ITA part) in WT/Let/584 which contains the HS2002 changes introduced to Hong Kong, China's schedule of concessions and which is in excess of the binding commitments. To accurately reflect Hong Kong, China's ITA commitments, the following rectification is proposed:

As a result, document WT/Let/1010 which contains the HS2007 changes should be rectified accordingly.

¹ This legal instrument (which is effective since 17 July 1997) contains the modifications introduced to Hong Kong, China's WTO schedule of concessions arising from the implementation of the ITA concluded in December 1996.

2. Arising from annual changes in tariff classification, Hong Kong, China has replaced a number of bound / partially bound / unbound lines under HS 8469 with HS 8469.0000 (viz. "typewriters other than printers of heading 8443; word-processing machines") and bound this new tariff line for simplicity since 2007. As a result, HS 8469.00 (comprising HS 8469.0010, 8469.0020 and 8469.0090) should have been fully bound in WT/Let/1010. To accurately reflect Hong Kong, China's commitments, the following rectification is proposed:

3. Arising from annual changes in tariff classification, Hong Kong, China has fully bound all tariff lines under HS 8528.72 since their creation in 2007. As a result, the whole HS 8528.72 (comprising HS 8528.7210 and 8528.7290), instead of only HS 8528.7210, should have been bound in WT/Let/1010. The following rectification should be made to accurately reflect Hong Kong, China's commitments:

4. Arising from annual changes in tariff classification, Hong Kong, China merged parts of a number of bound and unbound tariff lines to form a new tariff line HS 8536.7000 (viz. "connectors for optical fibres, optical fibre bundles or cables") in 2007. Hong Kong, China has fully bound this new tariff line for simplicity since then. As a result, the whole HS 8536.70 (comprising HS 8536.7010 and 8536.7090), instead of only HS 8536.7010, should have been bound in WT/Let/1010. The following rectification should be made to accurately reflect Hong Kong, China's commitments:

5. During the introduction of HS2007 changes to Hong Kong, China's WTO schedule of concessions, the tariff line HS 9503.0060 (viz. "puzzles of all kinds"), which was created by merging a number of unbound tariff lines (under HS 9503.60 in HS2002), was inadvertently bound. Hence, this tariff line should not have been bound in WT/Let/1010. The following rectification is therefore proposed:
