**SCHEDULE XIV – NORWAY**

WHEREAS the CONTRACTING PARTIES to the General Agreement on Tariffs and Trade 1947 adopted, on 26 March 1980, a Decision on Procedures for Modification and Rectification of Schedules of Tariff Concessions (BISD 27S/25);

WHEREAS in accordance with the provisions of the above-mentioned Decision, a draft containing modifications and rectifications to Schedule XIV – Norway was communicated to all Members of the World Trade Organization in document G/MA/TAR/RS/86 on 23 September 2002 as follows:

Norway hereby submits a notification of corrections to its tariff schedule, concerning minor changes to the Annex IV to the Pharmaceutical Agreement. The corrections are of a technical nature, as 5 - five – products were erroneously classified under the wrong HS subheading in the original notification.

The products concerned are shown in the table below. In our original submission, all products except the one identified by CAS number 57090-45-6 were classified within HS subheading 2905.49. The product with CAS number 1947-62-2 is the only product of those listed that fall within subheading 2905.49. All the other products belong to subheading 2905.50 (HS96). In the 2002 version of the HS, the subheading should read 2905.59.
