SCHEDULE XXXVIII - JAPAN

WHEREAS the CONTRACTING PARTIES to the General Agreement on Tariffs and Trade 1947 adopted, on 8 October 1991, a Decision on Procedures to Implement Changes in the Harmonized System (L/6905);

WHEREAS in accordance with the provisions of the above-mentioned Decision, a draft containing modifications and rectifications to Schedule XXXVIII - Japan was communicated to all Members of the World Trade Organization in document G/MA/TAR/RS/145 on 29 August 2008 and was approved on 29 November 2008;

IT IS HEREBY CERTIFIED that the modifications and rectifications to Schedule XXXVIII – Japan are established in conformity with the above-mentioned Decision.

The annexed modifications and rectifications to the Schedule become effective in accordance with the notification given to that effect by the Government of Japan to the Director-General of the World Trade Organization upon completion of Japan's internal procedures.

This Certification is deposited with the Director-General of the World Trade Organization, who shall promptly furnish a certified true copy to each Member of the World Trade Organization. It shall be registered in accordance with the provisions of Article 102 of the Charter of the United Nations.
