CERTIFICATION OF MODIFICATIONS AND RECTIFICATIONS

SCHEDULE XLII - ISRAEL

WHEREAS the CONTRACTING PARTIES to the General Agreement on Tariffs and Trade 1947 (the "GATT") adopted, on 26 March 1980, a Decision on Procedures for Modification and Rectification of Schedules of Tariff Concessions (L/4962)¹;

WHEREAS Contracting Parties to the GATT carried out negotiations with a view to introducing into Schedule XLII of Israel the Harmonized Commodity Description and Coding System (the "Harmonized System") pursuant to Article XXVIII of the GATT and the special procedures relating to the transposition of the current GATT concessions into the Harmonized System, adopted by the GATT Council on 12 July 1983 (BISD 30S/17);

WHEREAS in accordance with the provisions of the above-mentioned Decision, a draft of the consolidated Schedule XLII – Israel in the nomenclature of the Harmonized System was communicated to all Contracting Parties to the GATT in document SECRET/HS/31 on 22 January 1992 and SECRET/HS/31/Add.1 on 24 July 1996;

IT IS HEREBY CERTIFIED that the modifications and rectifications to Schedule XLII - Israel are established in conformity with the above-mentioned Decision.

The modifications in the annexed Schedule enter into force as of 24 October 1996, without prejudice to any modifications and rectifications made effective subsequent to that date and without prejudice to the Marrakesh Protocol to the GATT 1994 of 15 April 1994.

This Certification is deposited with the Director-General of the World Trade Organization, who shall promptly furnish a certified true copy to each Member of the World Trade Organization. It shall be registered in accordance with the provisions of Article 102 of the Charter of the United Nations.
