### ARTICLE XXVIII:5 NEGOTIATIONS

#### Schedule XIII - New Zealand

The following communication, dated 26 July 1989, has been received from the Permanent Mission of New Zealand.

It is recalled that New Zealand has notified (see document TAR/156) the CONTRACTING PARTIES that it reserved its rights, pursuant to the provisions of paragraph 5 of Article XXVIII of the General Agreement, to modify Schedule XIII - New Zealand, during the three year period commencing on 1 January 1988.

I now have the honour to notify the CONTRACTING PARTIES that New Zealand intends to modify the following concessions included in Schedule XIII - New Zealand.
