SCHEDULE CXXVII – GRENADA

WHEREAS the CONTRACTING PARTIES to the General Agreement on Tariffs and Trade 1947 adopted, on 26 March 1980, a Decision on Procedures for Modification and Rectification of Schedules of Tariff Concessions (BISD 27S/25);

WHEREAS in accordance with the provisions of the above-mentioned Decision, a draft containing modifications and rectifications to Schedule CXXVII – Grenada was communicated to all Members of the World Trade Organization in document G/MA/TAR/RS/91 on 7 February 2003, as follows:

Members will recall Grenada's request for Article XXVIII renegotiations notified in documents G/SECRET/16 dated 18 October 2002, G/SECRET/16/Add.1 dated 11 December 2002 and G/SECRET/16/Corr.1 dated 11 December 2002. Having engaged in the procedures established under Article XXVIII, the Government of Grenada wishes to report that the process is now at an end.

Pursuant to the Decision of 26 March 1980, the Government of Grenada respectfully requests that the Secretariat undertake the following changes to the country's schedule of commitments:
