**SCHEDULE LIX - SWITZERLAND-LIECHTENSTEIN**

*Addendum*

The following communication, dated 10 July 2017, is being circulated at the request of the delegation of Switzerland.

---

With reference to the negotiations held by Switzerland in connection with its notification, circulated in document G/SECRET/5 of 22 December 1995, in which it notified its intent to modify its concession in respect of the tariff quotas for wine (Nos. 23, 24 and 25), included in Schedule LIX - Switzerland-Liechtenstein, in accordance with the provisions of Article XXVIII of the GATT 1994 and pursuant to paragraphs 5 and 6 of the Guidelines on Procedures for Negotiations under Article XXVIII<sup>1</sup>, Switzerland has the honour to submit herewith the following documents:

- i. the report entitled "Negotiations relating to the Schedule of Switzerland-Liechtenstein", setting out the results of those negotiations; and
- ii. the final report entitled "Report on Negotiations under Article XXVIII".

In accordance with paragraph 8 of the Guidelines on Procedures for Negotiations under Article XXVIII, Switzerland will submit a draft Schedule to incorporate the changes resulting from the above-mentioned negotiations, pursuant to paragraph 1 of the Procedures for Modification and Rectification of Schedules of Tariff Concessions of 1980.<sup>2</sup>
