Lista XV - Pakistán

Se ha recibido de la Misión Permanente del Pakistán la siguiente comunicación, de fecha 29 de diciembre de 1994.

El Gobierno del Pakistán ha decidido mejorar sus concesiones como parte de los compromisos contraídos en la Ronda Uruguay en relación con los textiles y el vestido. Esas mejoras se realizarán mediante modificaciones de los compromisos incluidos en la Lista XV - Pakistán según figuran en el cuadro adjunto.¹

Si en el plazo de treinta días contados a partir de la fecha del presente documento no se notifica a la Secretaría ninguna objeción, las rectificaciones de la Lista XV - Pakistán se considerarán aprobadas y se anexarán al Protocolo Adicional al Protocolo de Marrakech anexo al Acuerdo General sobre Aranceles Aduaneros y Comercio de 1994.
