CERTIFICATION OF MODIFICATIONS AND RECTIFICATIONS TO  
SCHEDULE CLIII – THE SEPARATE CUSTOMS TERRITORY OF TAIWAN, PENGHU,  
KINMEN AND MATSU

WHEREAS the CONTRACTING PARTIES to the General Agreement on Tariffs and Trade 1947 adopted, on 26 March 1980, a Decision on Procedures for Modification and Rectification of Schedules of Tariff Concessions (BISD 27S/25);

WHEREAS in accordance with the provisions of the above-mentioned Decision, a draft containing modifications and rectifications to **Schedule CLIII – The Separate Customs Territory of Taiwan, Penghu, Kinmen and Matsu** was communicated to all Members of the World Trade Organization in document G/MA/TAR/RS/450 on 16 November 2016 pursuant to the Declaration on the Expansion of Trade in Information Technology Products (WT/L/956);

WHEREAS no objections to the proposed modifications and rectifications were received within three months from the date of issue of the aforementioned document, and Chinese Taipei has completed its domestic procedures, as notified in a letter dated 24 February 2017 and circulated to Members in document G/MA/TAR/RS/450/Add.1 on 28 February 2017;

IT IS HEREBY CERTIFIED that the modifications and rectifications to **Schedule CLIII – The Separate Customs Territory of Taiwan, Penghu, Kinmen and Matsu** are established in conformity with the above-mentioned Decision.

The annexed Schedule is effective as of **24 February 2017**.

I hereby furnish a certified true copy of the above-mentioned modifications and rectifications to each Member of the World Trade Organization. This certification shall be registered in accordance with the provisions of Article 102 of the Charter of the United Nations.
