ETABLISSEMENT D'UNE NOUVELLE LISTE XXI - INDONESIE

La Mission permanente de l'Indonésie a adressé au secrétariat la communication ci-après en date du 27 novembre 1981.

J'ai l'honneur de vous transmettre ci-joint copie des accords bilatéraux¹ que l'Indonésie a conclus avec les Etats-Unis et l'Australie au sujet de l'établissement d'une nouvelle Liste XXI - Indonésie.²

J'ai également l'honneur de porter à votre connaissance que le 17 novembre 1981 les délégations de l'Indonésie et de la Commission des Communautés européennes ont terminé à Bruxelles leurs négociations au titre de l'article XXVIII. Les résultats de ces négociations sont indiqués dans le rapport ci-joint.¹ Il convient de noter que ces résultats s'entendent sous réserve de l'approbation du Conseil des Ministres de la Commission.
