Domestic Support

Domestic support measures applicable in Belize are meeting the criteria set forth in Annex 2 as well as in paragraph 18 of part 1 of section L of the Agreement relating to special and differential treatment.

Domestic support measures covered by Annex 2 for which exemptions from reduction commitments are sought are laid out in Table 2.

Domestic support measures which are to be exempted from reduction commitments according to special and differential treatment as provided in paragraph 18 are indicated in Table 3.

Export Subsidies

The Government of Belize does not grant any of the export subsidies subject to reduction commitments as laid out in Annex 7 of Section L of the Agreement.
