Schedule LXXV - Philippines

Addendum

The following communication, dated 5 December 1994, has been received from the Permanent Mission of the Philippines.

I refer to G/RS/10 circulated by the GATT Secretariat on 14 October 1994 which proposed technical corrections on live swine, live poultry, pork and poultry meat relative to Section 1B of the above-mentioned Schedule.

The technical correction on live swine has been accepted by interested trading partners leading to the issuance of a Procès-Verbal dated 30 November 1994. However, requests for clarification/objections were made with respect to the proposed corrections on live poultry, pork and poultry meat within the 30-day time-limit.

In this connection, we wish to address the reservations raised through the submission of revised figures for pork and poultry meat (Annex A)¹ which are based on USDA statistics. With respect to live poultry, the proposed corrections are the same as those reflected in G/RS/10. On this last item, we wish to reiterate that the figures in Section 1B of the above-mentioned Schedule were incorrect due to the inclusion under live poultry of quantities that logically belong to poultry meat, hence the new figures for poultry meat in Annex A.

If no objection is notified to the Secretariat within 30 days from the date of this document, the rectifications to Schedule LXXV - Philippines will be deemed to be approved and will be formally issued as a Procès-Verbal.
