WHEREAS in accordance with the provisions of the above-mentioned Decision, a draft containing modifications and rectifications to Schedule **LIX - Switzerland-Liechtenstein** was communicated to all Members of the World Trade Organization in document G/MA/TAR/RS/359 on 16 July 2014, and no objections to the proposed modifications and rectifications were received within three months from the date of issue of the aforementioned document;

IT IS HEREBY CERTIFIED that the modifications and rectifications to Schedule **LIX - Switzerland-Liechtenstein** are established in conformity with the above-mentioned Decision.
