Addendum

La siguiente comunicación, de fecha 17 de diciembre de 2012, se distribuye a petición de la delegación de la Unión Europea.

En relación con las negociaciones mantenidas por la Unión Europea acerca de su notificación, distribuida en el documento G/SECRET/32, de 16 de junio de 2009, en la que informaba de su propósito de modificar su concesión respecto de las subpartidas arancelarias 1602 20 10, 1602 32 11, 1602 32 30, 1602 32 90, 1602 39 21, 1602 39 29, 1602 39 40 y 1602 39 80 incluidas en la Lista CXL de las Comunidades Europeas, de conformidad con las disposiciones del artículo XXVIII del GATT de 1994 y el párrafo 5 de las Directrices relativas al procedimiento para las negociaciones en virtud del artículo XXVIII (documentos C/113 y Corr.1, de 10 de noviembre de 1980, en adelante "las Directrices"), la Unión Europea tiene el honor de adjuntar a la presente los siguientes documentos¹:

- i) las cartas conjuntas, redactadas según el modelo que figura en los anexos A y B a que se hace referencia en el párrafo 5 de las Directrices, firmadas por la Unión Europea al término de cada negociación bilateral celebrada, respectivamente, con el Brasil y Tailandia;
- ii) el informe titulado "Negotiations relating to the schedule of the European Union" (Negociaciones sobre la Lista de la Unión Europea), que presenta los resultados de esas negociaciones, redactado según el modelo que figura en el anexo B a que se hace referencia en el párrafo 5 de las Directrices; y
- iii) un informe final titulado "Report on Negotiations under Article XXVIII" (Informe de las negociaciones efectuadas en virtud del artículo XXVIII), redactado según el modelo que figura en el anexo C a que se hace referencia en el párrafo 6 de las Directrices, que debe presentarse tras la conclusión de todas las negociaciones en virtud del párrafo 1 del artículo XXVIII.

Report by the delegation of the European Union relating to negotiations under Article XXVIII with respect to Schedule CXL of the European Union.

Although contacted by Argentina within the 90 day period referred to in paragraph 4 of the Guidelines on Procedures for Negotiation under Article XXVIII (documents C/113 and Corr.1 of 10 November 1980), the EU did not hold consultations with Argentina as Argentina did not have Initial Negotiating Rights, a principal supplying interest or a substantial interest in any of the products that the EU had notified in its proposal for modifying the existing bindings.

No other WTO Member expressed its interest to enter into negotiations in accordance with the provisions of Article XXVIII GATT 1994 within the 90 day period referred to in paragraph 4 of the Guidelines on Procedures for Negotiations under Article XXVIII (documents C/113 and Corr.1 of 10 November 1980); therefore, the EU considers its negotiations under Article XVIII to be completed.
