Addendum

The following communication, dated 21 December 2018, is being circulated at the request of the delegation of Switzerland.

With reference to the negotiations held by Switzerland in connection with its notification, circulated in document G/SECRET/4 of 7 August 1995, in which it notified its intent to modify its concession in respect of HS tariff heading ex0809.1090 (apricots, otherwise packed, imported from 01.07 to 31.08), included in Schedule LIX – Switzerland-Liechtenstein, in accordance with the provisions of Article XXVIII of the GATT 1994 and pursuant to paragraphs 5 and 6 of the Guidelines on Procedures for Negotiations under Article XXVIII¹, Switzerland has the honour to submit herewith the following documents:

- i. the report entitled "Negotiations relating to the Schedule of Switzerland-Liechtenstein", setting out the results of those negotiations; and
- ii. the final report entitled "Report on Negotiations under Article XXVIII".

In accordance with paragraph 8 of the Guidelines on Procedures for Negotiations under Article XXVIII, Switzerland will submit a draft Schedule to incorporate the changes resulting from the above-mentioned negotiations, pursuant to paragraph 1 of the Procedures for Modification and Rectification of Schedules of Tariff Concessions of 1980.²
