### Lista XII - India

### Addendum

Se ha recibido de la Misión Permanente de la India la siguiente comunicación, de fecha 29 de diciembre de 1999.

A raíz de las negociaciones y consultas conexas celebradas por la India en relación con su propuesta de incrementar los tipos consolidados respecto de determinados productos contenidos en la Lista XII, en virtud del párrafo 1 del artículo XXVIII del GATT de 1994 (notificación distribuida como documento G/SECRET/8, de fecha 2 de septiembre de 1996), se adjuntan a la presente los documentos siguientes, de conformidad con el párrafo 5 de las Directrices relativas al *Procedimiento para las negociaciones en virtud del artículo XXVIII* (documentos C/113 y Corr.1, de 10 de noviembre de 1980) en conexión con la Decisión sobre los *Procedimientos para la modificación o rectificación de las listas de concesiones arancelarias* (Decisión de 26 de marzo de 1980, documento L/4962):

- i) las cartas conjuntas<sup>1</sup>, redactadas según figuran en el anexo A, firmadas por la India al término de cada negociación bilateral celebrada, respectivamente, con Australia, las Comunidades Europeas y los Estados Unidos de América; y
- ii) los informes<sup>1</sup>, redactados según figuran en el anexo B, que acompañan a las respectivas cartas conjuntas.

Se adjunta igualmente el informe final<sup>1</sup>, redactado según el modelo que figura en el anexo C a que se hace referencia en el párrafo 6 de las Directrices, que debe presentarse tras la conclusión de todas las negociaciones en virtud del párrafo 1 del artículo XXVIII.

### NEGOTIATIONS UNDER ARTICLE XXVIII

Report by the Delegation of India relating to negotiations under Article XXVIII of the GATT 1994 with respect to Schedule XII of India.

1. Negotiations resulted in agreement with:

3. Consultations have been held with:

Consultations were also held with Argentina in respect of the product "*1507.10 Soyabean oil (crude oil, whether or not degummed)*". However, it may be noted that India has withdrawn the product "*1507.10 Soyabean oil (crude oil, whether or not degummed)*" from its Article XXVIII notification circulated as document G/SECRET/8 dated 2 September 1996.

New Zealand had also requested consultations. However, in the bilateral meetings held with New Zealand on its request, it was pointed out that since New Zealand did not have either Initial Negotiating Rights, principal supplying interest or substantial interest in any of the products that India had notified in its proposal for increasing the existing bindings, there was no need to hold substantive Article XXVIII negotiations with New Zealand.

Since no other WTO Member expressed its interest to enter into negotiations, India considers its negotiations under Article XVIII to be completed.
