ARTICLE XXVIII:1 NEGOTIATIONS

Schedule XII - India

The following communication, dated 30 August 1996, has been received from the Permanent Mission of India.

In accordance with the provisions and procedures of Article XXVIII.1 of GATT 1994, the Government of India hereby notifies that it intends to modify or withdraw certain concessions on items included in WTO Schedule XII.

The Government of India is prepared to enter into negotiations and/or consultations with the interested Members of the WTO (including initial negotiating right holders) under Article XXVIII for the modification of its concessions as indicated in the Annex.¹

The Annex also contains import statistics for the most recent three year period.
