PROCES-VERBAL OF RECTIFICATION

In documents G/RS/5 and G/RS/10 proposed rectifications to Schedule LXXV -Philippines annexed to the Marrakesh Protocol to the General Agreement on Tariffs and Trade 1994 were circulated to the Participants in the Uruguay Round of Multilateral Trade Negotiations.
