#### ARTICLE XXVIII:5 NEGOTIATIONS

#### Schedule I - Australia

The following communication, dated 31 August 1992, has been received from the Permanent Mission of Australia.

I have the honour to refer to GATT document TAR/183, dated 3 October 1990, in which Australia notified the CONTRACTING PARTIES that under Article XXVIII:5 of the General Agreement it reserved the right to modify its schedule of concessions during the three year period commencing on 1 January 1991.

Pursuant to that notification and on instructions from my Government I have the honour to inform you that Australia intends, in accordance with Article XXVIII:5 of the General Agreement, to modify a number of concessions specified in Attachment A.

The concessions being withdrawn are currently accorded in specific rate terms. It is Australia's intention to rebind the items concerned in ad valorem terms. Details of the proposed new concessions are specified in Attachment <sup>B1</sup> together with the ad valorem equivalents of the existing specific rate concessions.

Tables showing relevant trade statistics are also attached to this notification (Attachment C).

Australia is prepared to enter into negotiations or consultations in accordance with the relevant provisions of Article XXVIII. Any contracting party which considers that it has an interest in these concessions is requested to so indicate as soon as possible and in any event within a period of ninety days from the date of this document.
