CERTIFICATION OF MODIFICATIONS AND RECTIFICATIONS

SCHEDULE CIII - CAMEROON

WHEREAS the CONTRACTING PARTIES to the General Agreement on Tariffs and Trade 1947 adopted, on 26 March 1980, a Decision on Procedures for Modification and Rectification of Schedules of Tariff Concessions (L/4962)¹;

WHEREAS the CONTRACTING PARTIES to the General Agreement on Tariffs and Trade 1947 agreed on procedures for the finalization and verification of Uruguay Round schedules (MTN.TNC/W/131);

WHEREAS in accordance with the above-mentioned process, a draft containing modifications to Schedule CIII - Cameroon was communicated to all Members of the World Trade Organization and verified on 24 April 1995 (G/C/M/3 and G/C/M/3/Corr.1);

WHEREAS the entry into force of these modifications was dependent upon the entry into force of a Protocol Supplementary to the Marrakesh Protocol to the General Agreement on Tariffs and Trade 1994, which Protocol Supplementary did not come into being;

WHEREAS provision should now be made for the entry into force of these modifications by means of a Certification, as agreed by the Council for Trade in Goods at its meeting on 10 November 2005 (G/C/M/82);

IT IS HEREBY CERTIFIED that the modifications in the annexed Schedule are deemed established in conformity with the above-mentioned Decision.

The annexed modifications enter into force as of 24 April 1995, without prejudice to any modifications and rectifications made effective subsequent to that date.

This Certification is deposited with the Director-General of the World Trade Organization, who shall promptly furnish a certified true copy to each Member of the World Trade Organization. It shall be registered in accordance with the provisions of Article 102 of the Charter of the United Nations.
