AU PROTOCOLE DE MARRAKECH

Liste LXXIX - Thaïlande

La Mission permanente de la Thaïlande a fait parvenir au secrétariat la communication ci-après, en date du 3 novembre 1994.

J'ai l'honneur de vous faire savoir que la Thaïlande souhaite apporter certaines corrections techniques à la Partie I, Section I-A, de la Liste LXXIX - Thaïlande. Ces corrections concernent deux lignes tarifaires - SH 0905.00 Vanille et 1209.24 Graines de pâturin des prés du Kentucky (*Poa Pratensis* L.) - et consistent à rectifier une erreur typographique et une omission involontaire. Les annexes A et B¹ contiennent des précisions et des explications à ce sujet.

Si aucune objection n'est notifiée au secrétariat dans un délai de 30 jours à compter de la date du présent document, les rectifications apportées à la Liste LXXIX - Thaïlande seront considérées comme approuvées et feront l'objet d'un procès-verbal officiel.

ANNEX B

PROPOSED TECHNICAL CORRECTIONS: PART I, SECTION I-A OF
SCHEDULE LXXIX - THAILAND

- (1) HS 0905.00
 - Column 4: replacement of 7% ad-valorem bound rate with 27%.
- (2) HS 1209.24
 - Columns 3, 4 and 5: insertion of base rate at 40%, bound rate at 30% and implementation period of 1995/2004 respectively.

EXPLANATION

- (1) HS 0905.00

Thailand's 14 December 1993 Draft Schedule, and its 15 February 1994 Draft Final Schedule which had been verified in March 1994, both indicate the level of bound rate of duty at 27, 14.85 B/kg. However, due to a typing error, our Final Schedule as attached to the Marrakesh Protocol shows the level of ad-valorem bound rate at 7% where it should have been 27%. Therefore, rectification should be made by replacing 7% rate with 27%.

- (2) HS 1209.24

With respect to this tariff item, our Schedule of 14 December 1993 shows the base rate of duty at 40% and the bound rate at 30%, the same relevant figures as of other items under the product group HS 1209. However, in our Draft Schedule of 15 February 1994 and our Final Schedule, while the same level of tariff concessions are retained for those other items, only the HS number and description of this product item are shown but other relevant columns are left blank simply as a result of an oversight.

In order to maintain our concessions regarding this tariff item, we propose to install the base rate of 40%, the bound rate of 30% and the implementation period from 1995 to 2004 in the Schedule LXXIX - Thailand.
