Lista XV - Pakistán

Se ha recibido la siguiente comunicación de la Misión Permanente del Pakistán.

Se presenta la siguiente comunicación a título de complemento de nuestra anterior comunicación de 29 de diciembre de 1994 relativa a las modificaciones de la Lista del Pakistán (Lista XV - Pakistán), distribuida el 13 de enero de 1995 por conducto del Comité Preparatorio de la OMC con la signatura G/SP/10.

A raíz de las observaciones formuladas por algunas delegaciones, se ha preparado la versión revisada de estas modificaciones que se adjunta a la presente para que se distribuya a los Miembros.¹

Si en el plazo de 90 días contados a partir de la fecha del presente documento no se notifica a la Secretaría ninguna objeción, las rectificaciones de la Lista XV - Pakistán se considerarán aprobadas y se anexarán al Protocolo Adicional al Protocolo de Marrakech anexo al Acuerdo General sobre Aranceles Aduaneros y Comercio de 1994.
