## RECTIFICACIONES Y MODIFICACIONES DE LAS LISTAS

### LISTA XXXIX - MALASIA

La siguiente comunicación, de fecha 23 de abril de 2021, se distribuye a petición de la delegación de Malasia.

---

De conformidad con la Decisión sobre los procedimientos para la modificación o rectificación de las Listas de concesiones arancelarias, de 1980<sup>1</sup>, mediante esta comunicación Malasia presenta propuestas de rectificaciones técnicas de su Lista XXXIX que figuran en el apéndice 2.<sup>2</sup>

Una rectificación de la Lista de Malasia certificada en el documento WT/Let/1243 de 28 de febrero de 2017 ya había corregido varios errores e incoherencias resultantes de la transposición de esta Lista al SA 1996<sup>3</sup>. Dada la secuencia en la que tuvieron lugar las transposiciones al SA y la rectificación, estos cambios no se han reflejado todavía en la transposición al SA 2002 de la Lista de concesiones de Malasia que fue certificada en el documento WT/Let/793 de 24 de junio de 2011.

Como consecuencia de ello, es necesario rectificar nuevamente el texto auténtico de la transposición al SA 2002 para corregir estos errores. Con la asistencia de la Secretaría de la OMC, Malasia ha preparado una rectificación, que tiene por objeto lo siguiente:

- i) corregir el derecho consolidado correspondiente a una línea arancelaria a fin de reflejar el nivel consignado en su Lista de la Ronda Uruguay;
- ii) cambiar el código de consolidación de nueve líneas arancelarias de conformidad con su Lista de la Ronda Uruguay;
- iii) borrar la línea arancelaria 4407.29.943 para reflejar mejor su Lista de la Ronda Uruguay;
- iv) armonizar la nomenclatura utilizada para los aranceles consolidados en la Lista de Malasia conforme al SA 2002 con su estructura de aranceles aplicados para las líneas arancelarias de 12 subpartidas del Capítulo 48 del SA (papel y productos de papel), lo que simplificaría considerablemente la comparación de los aranceles consolidados y aplicados correspondientes a esos productos;
- v) corregir el derecho consolidado y/o la designación del producto de 11 líneas arancelarias para simplificar la complejidad de la información contenida en la Lista de concesiones conforme al SA 2002 de Malasia.

En el apéndice 1<sup>2</sup> figuran notas explicativas detalladas. Malasia desea reiterar que las rectificaciones propuestas son de carácter puramente formal y no alteran el alcance de las concesiones que acordó durante la Ronda Uruguay.

Si en el plazo de tres meses contados a partir de la fecha del presente documento no se notifica a la Secretaría ninguna objeción, las rectificaciones y modificaciones de la Lista XXXIX - Malasia se considerarán aprobadas y serán formalmente certificadas.

### ATTACHMENT 1 – EXPLANATORY NOTE

Based on assistance received from the WTO Secretariat, Malaysia proposes to rectify the relevant discrepancies as follows:

**(i) Correcting the bound duty for one tariff line in order to reflect the level recorded in Malaysia's UR Schedule**

As a result of the rectification in document WT/Let/1243 of February 2017, the bound duty of one tariff line was not correctly reflected in Malaysia's HS2002 transposition certified in WT/Let/793 of June 2011. The following correction is required to reflect the original bound duty as listed in Malaysia's UR Schedule:

**(iii) Deleting tariff line 440729943 in accordance with Malaysia's UR Schedule**

Malaysia's Uruguay Round Schedule includes a concession under HS92 subheading 440721 for Yellow Meranti. According to the HS96 correlation tables<sup>1</sup>, it should have been classified under HS96 subheading 440726 " - - White Lauan, White Meranti, White Seraya, Yellow Meranti and Alan" (emphasis added). However, this concession was not correctly reflected in Malaysia's HS2002 transposition certified in WT/Let/793 and was incorrectly reflected under HS2002 subheading 4407.29, which does not cover this type of wood. The following correction is required to reflect the original commitment for this tariff line as listed in Malaysia's UR schedule and remove the incorrect reference:

**(iv) Aligning the nomenclature used for the bound tariffs in Malaysia's schedule in HS2002 to its applied tariff structure for tariff lines under 12 subheadings in HS chapter 48 for paper and paper products**

In the course of verifying the Harmonized System 2002 (HS2002) transposition files prepared by the Secretariat, Malaysia identified 13 subheadings in HS chapter 48 for paper and paper products where the nomenclature used is very detailed and does not correspond to Malaysia's applied tariff structure. Malaysia considers that it is desirable to align the tariff structure of HS2002 subheadings 480220, 480258, 480261, 480262, 480269, 480512, 480519, 480525, 480591, 480592, 480593 and 480890 to its applied tariff structure, which would considerably facilitate ensuring that the bound rates are not exceeded. Although the Schedules of concessions do not normally list the unbound parts of the affected subheadings, they are shown below for a better understanding of the full coverage of each of them. The following correction reflects the original commitments for these tariff lines as listed in Malaysia's UR Schedule:
