## GENEVA (1988) PROTOCOL TO THE GENERAL AGREEMENT ON TARIFFS AND TRADE

### Addendum

1. The Geneva (1988) Protocol to the General Agreement on Tariffs and Trade, contained in document L/6363, was opened for acceptance on 10 June 1988.
2. On 29 June 1988, the delegation of Thailand has annexed to the Protocol a consolidated Schedule LXXIX in the nomenclature of the Harmonized Commodity Description and Coding System (Harmonized System).
3. Two copies of the consolidated Schedule LXXIX - Thailand<sup>1</sup> in the Harmonized System nomenclature are being sent to each contracting party.
4. Further schedules will be annexed to the Protocol as delegations conclude their Article XXVIII negotiations related to the introduction of the Harmonized System.
5. The printed volumes containing the Geneva (1988) Protocol and the annexed schedules will be distributed in due course after the time-limit for annexation of schedules indicated in paragraph 3(a) of the Protocol has lapsed, at which time a certified copy of these volumes will be transmitted to all contracting parties. In addition, one further copy of the printed volumes will be transmitted free of charge to these countries. Additional copies will be available for sale in the secretariat.
