Pursuant to the procedures for the implementation of the 1996 changes in the Harmonized System, the Permanent Mission of Thailand to the World Trade Organization hereby submits some corrections¹ to the Schedule LXXIX of Thailand (G/SECRET/HS96/17/Rev.2 of 27 November 2001, G/SECRET/HS96/17/Rev.2/Corr.1 of 18 December 2003, G/SECRET/HS96/17/Rev.2/Add.1 of 18 December 2003 and G/SECRET/HS96/17/Rev.2/Add.2 of 10 August 2006).
