Addendum

The following communication, dated 17 February 2011, is being circulated at the request of the delegation of Argentina.

I have the honour to write to you in connection with the introduction of changes in the 1996 Harmonized System into the schedules of tariff concessions annexed to the WTO Agreement.

As you know, the General Council, at its meeting on 2 August 2010 (WT/L/801), approved an extension of the waiver under Article II of the GATT 1994 in order to enable Argentina to conclude the exchange of information with the European Union concerning pending comments on the transposition to HS96 (G/SECRET/HS96/30 of 16 October 1996). Accordingly, and given that an understanding has been reached, I have pleasure in attaching hereto an annex containing the changes agreed with the European Union for circulation to Members. These changes are additional to those notified at the appropriate time by means of document G/SECRET/HS96/30/Corr.1 of 16 May 2000.

If no objection is notified to the Secretariat within 90 days from the date of this document, the changes to Schedule LXIV - Argentina will be deemed to be approved and will be formally certified.
