Addendum

The following communication, dated 9 March 1999, has been received from the Permanent Mission of Korea.

The following changes have been made according to the requests by one Member regarding the agricultural part of the Korean Loose-Leaf Schedule including modifications from the Harmonized System 1996 changes. The changes are related to minor technical errors such as inappropriate descriptions, omissions, etc. which do not cause any change in Korea's tariff concession schedule.

- 1. SSG item 1002.00.0000: Changed 1002.00.0000 to ex1002.00.0000 in the list of SSG items (115 items, 10-digit HS) of the document G/SECRET/HS96/4/Corr.2/Rev.1, dated on 3 March 1997.
- 2. HS96 1106.30.0000: Changed the description "Of the products of heading No.08" to "Of the products of Chapter 08".
- 3. HS96 1212: Inserted the description in the last part, "kind used primarily for human consumption, not elsewhere specified or included".
- 4. HS96 1510.00.0000: Changed the description of the heading to "Other oils and their fractions, obtained solely from olives, whether or not refined, but not chemically modified, including blends of these oils or fractions with oils or fractions of heading No. 1509".
- 5. Pre-HS96 heading 1520.90: Reclassified HS96 2905.45, which was located in SECTION II Other Products, as part of SECTION I Agricultural products of our HS96 schedule.
- 6. HS96 heading 1901: Added "cocoa or containing less than 5% by weight..." after "food preparations of goods of heading Nos. 0401 to 0404, not containing....".
- 7. After HS96 heading 2008.80.0000: Added "2008.9 Other, including mixtures other than those of subheading No. 2008.19" after HS96 heading 2008.80.0000.
