Addendum

La Mission permanente de l'Islande a fait parvenir au Secrétariat la communication ci-après, datée du 4 octobre.

Conformément aux procédures concernant la mise en œuvre des modifications apportées au Système harmonisé en 1996, nous avons l'honneur de vous adresser ci-joint un addendum à la Liste LXII – Islande.¹

Cet addendum a été établi à la suite de consultations approfondies avec des experts des Communautés européennes. Les parties sont convenues des modifications spécifiques suivantes à apporter à la version SH96 de la Liste communiquée au Secrétariat de l'OMC. Nous indiquons ci-après les modifications spécifiques apportées à notre Liste à la suite de ces consultations.

La Mission permanente vous saurait gré de bien vouloir distribuer aux Membres de l'OMC la présente communication ainsi que l'addendum susmentionné.

Si aucune objection n'est notifiée au Secrétariat dans un délai de 90 jours à compter de la date du présent document, les modifications de la Liste LXII – Islande seront considérées comme approuvées et seront officiellement certifiées.

1. Tariff No. 1209.1109 Bound rate of duty 0% *ad valorem* should be inserted.
2. Tariff No. 1806.3101 Bound rate of duty 39% *ad valorem* should be inserted.
3. Tariff No. 2104.2001 Bound rate of duty reduced from specific duty of 3,97 SDR/kg and 117% *ad valorem* to specific duty of 0,94 SDR/kg and 117% *ad valorem*.
