Section I-B Tariff Quotas

Page 16369 of certified copy, column "Description of product":

The following text:

" - Fresh cheese (unripened or uncured), including whey cheese and curd : -- Pizza cheese, frozen, cut into pieces each weighing not more than 1 gram, in containers of minimum 5 kg, with a moisture content of 52%, and a fat content of minimum 38%"

is replaced by:

"- Fresh cheese (unripened or uncured), including whey cheese and curd: -- Pizza cheese, frozen, cut into pieces each weighing not more than 1 gram, in containers with a net content of 5 kg or more, of a water content, by weight, of 52% or more, and a fat content by weight in the dry matter of 38% or more".
