WHEREAS the CONTRACTING PARTIES to the General Agreement on Tariffs and Trade 1947 adopted, on 8 October 1991, a Decision on Procedures to Implement Changes in the Harmonized System (L/6905);

WHEREAS in accordance with the provisions of the above-mentioned Decision, the draft containing the rectification to Schedule LXXVII - Mexico was communicated to all Members of the World Trade Organization in document G/MA/TAR/RS/7 on 17 July 1996;

IT IS HEREBY CERTIFIED that the rectification to Schedule LXXVII - Mexico is established in conformity with the above-mentioned Decision.

The annexed rectification shall become effective on 17 October 1996.
