SCHEDULE CLXXIII – EUROPEAN UNION²

WHEREAS the CONTRACTING PARTIES to the General Agreement on Tariffs and Trade 1947 adopted, on 26 March 1980, a Decision on Procedures for Modification and Rectification of Schedules of Tariff Concessions (BISD 27S/25);

WHEREAS in accordance with the provisions of the above-mentioned Decision, a draft containing modifications and rectifications to **Schedule CLXXIII – European Union** was communicated to all Members of the World Trade Organization in document G/MA/TAR/RS/357 dated 25 April 2014, as subsequently corrected and amended in documents G/MA/TAR/RS/357/Corr.1 dated 19 February 2015, G/MA/TAR/RS/357/Add.1 dated 1 September 2016, and G/MA/TAR/RS/357/Corr.2 dated 19 September 2016;

WHEREAS none of the original reservations to document G/MA/TAR/RS/357 remain, and no objections to the proposed modifications and rectifications were received within three months from the date of issue of document G/MA/TAR/RS/357/Add.1;

IT IS HEREBY CERTIFIED that the modifications and rectifications to **Schedule CLXXIII – European Union** are established in conformity with the above-mentioned Decision.

The annexed Schedule is effective as of **1 December 2016**.

I hereby furnish a certified true copy of the above-mentioned modifications and rectifications to each Member of the World Trade Organization. This certification shall be registered in accordance with the provisions of Article 102 of the Charter of the United Nations.
