### MARRAKESH AGREEMENT ESTABLISHING THE WORLD TRADE ORGANIZATION DONE AT MARRAKESH ON 15 APRIL 1994

### PROCES-VERBAL OF RECTIFICATION

In document G/RS/24, dated 15 December 1994, proposed rectifications to Schedule V: Canada, annexed to the Marrakesh Protocol to the General Agreement on Tariffs and Trade 1994, were circulated to the participants in the Uruguay Round of Multilateral Trade Negotiations.

Considering that the objections which were raised to these rectifications, during the thirty-day period established for such objections, have been withdrawn, these rectifications have been approved. The relevant text is annexed hereto.

Acting as depositary of the Marrakesh Agreement Establishing the World Trade Organization, I have caused these rectifications to be made in the authentic text and have initialled these rectifications in the relevant schedule annexed to the Marrakesh Protocol.

In witness whereof I have signed the present Procès-Verbal of Rectification, drawn up in the English, French and Spanish languages, on 5 April 1995.

### SCHEDULE V: CANADA

### **Technical Corrections**

Section 1-A: Tariffs

#### General

Chapter notes from Canada's tariff schedule have been included in the schedule for completeness. In addition, headnotes 4 and 5 have been incorporated as part of chapter notes for Chapters 16 and 19 respectively.

Supplementary Note 2 under Chapter 16 chapter notes (formerly headnote 4) has been reworded to be clearer in meaning and now reads as follows:

"Specially defined mixtures" of tariff items 1602.31.11, 1602.31.92 and 1602.39.92 means a product containing partially or fully cooked, including par-fried, chicken or turkey wherein 13% or more of the total weight of the product is comprised of goods other than the following: chicken, turkey, breading, batter, oil, glazing, sauces, other coatings and bastes, and any added water (including that used in marination, glazing, sauces, other coatings, bastes, breading and batter). For the purposes of this definition, the weight of all ingredients shall be taken from the product specification sheets for that product as approved by Agriculture and Agri-Food Canada for product labelling purposes".

Supplementary Note 1 under Chapter 19 headnotes has replaced the former headnote 5. Under "Products falling within tariff items" tariff item 1901.20.22 has been added. Under b)2 the phrase "(in cans or jars)" has replaced "(canned or jarred)".

Various ad valorem rates for tariffied items which were originally set at two decimal places have been rounded off to one decimal place. For example, under 0207.10.18, column 4, 5.38% has been converted to 5.4%, and under 0401.10.10, column 4, 7.53% has been converted to 7.5%.
