CERTIFICATION OF RECTIFICATIONS

SCHEDULE LXXXIV – BOLIVIA

WHEREAS the CONTRACTING PARTIES to the General Agreement on Tariffs and Trade 1947 adopted, on 26 March 1980, a Decision on Procedures for Modification and Rectification of Schedules of Tariff Concessions (BISD 27S/25);

WHEREAS in accordance with the provisions of the above-mentioned Decision, a draft containing the rectifications to Schedule LXXXIV – Bolivia (WT/Let/204) was communicated to all Members of the World Trade Organization in document G/MA/TAR/RS/49 on 15 June 1998;

IT IS HEREBY CERTIFIED that the following rectifications to Schedule LXXXIV-Bolivia are established in conformity with the above-mentioned Decision:

Subheading 0102 90 10 – Para lidia, the figure "40%" in column 3, should read "30%".

Subheading 0206 30 00 – De la especie porcina, frescos o refrigerados, add "NZ" in column 5.

Subheading 0402 29 – Las demás. Nothing should appear in columns 3, 5 and 6.

Item 0402 29 90 00 – Las demás. Add "40%" (column 3), "UE, NZ, US, CA" (column 5), and "BO/89" (column 6).

Subheading 4408 10 – De coníferas. Nothing should appear in columns 3, 5 and 6.

The above rectifications shall become effective on 15 September 1998.

This Certification is deposited with the Director-General of the World Trade Organization, who shall promptly furnish a certified true copy to each Member of the World Trade Organization. It shall be registered in accordance with the provisions of Article 102 of the Charter of the United Nations.
