WHEREAS the CONTRACTING PARTIES to the General Agreement on Tariffs and Trade 1947 adopted, on 26 March 1980, a Decision on Procedures for Modification and Rectification of Schedules of Tariff Concessions (BISD 27S/25);

WHEREAS in accordance with the provisions of the above-mentioned Decision, a draft containing a rectification to Schedule LXXVI – Colombia was communicated to all Members of the World Trade Organization in document G/MA/TAR/RS/51 on 29 July 1998;

IT IS HEREBY CERTIFIED that the rectification to Schedule LXXVI – Colombia is established in conformity with the above-mentioned Decision:

The annexed rectification shall become effective on 15 July 2000.
