SCHEDULE XCVI - SLOVENIA

WHEREAS the CONTRACTING PARTIES to the General Agreement on Tariffs and Trade 1947 adopted, on 8 October 1991, a Decision on Procedures to Implement Changes in the Harmonized System (L/6905),

WHEREAS in accordance with the provisions of the above-mentioned Decision, a draft containing modifications and rectifications to Schedule XCVI - Slovenia was communicated to all Members of the World Trade Organization in document G/SECRET/HS96/23 on 30 April 1996 and in documents G/SECRET/HS96/23/Corr 1 and G/SECRET/HS96/23/Corr 2,

IT IS HEREBY CERTIFIED that the modifications and rectifications to Schedule XCVI – Slovenia are established in conformity with the above-mentioned Decision

SECTION I Agricultural Products

SECTION I - A Tariffs

Notes for Section I

1. Agricultural products, which are not included in this Schedule, but are a part of the Customs Tariff of the Republic of Slovenia, are bound at the ad valorem rate of 27%.
2. The reductions of tariffs and any expansion of tariff quotas provided for in Section I A, subcolumn 2, or Section I B, subcolumn 4, of this Schedule, shall be implemented in equal annual instalments in a period of 6 years beginning in 1995 and ending in the year 2000.
3. Section I includes products covered by tariff headings referred to in Annex I to the Agreement on Agriculture ("Product Coverage").
4. In the column 3 of the Section I of this Schedule (Rate of duty), subcolumn (1) means that the duty rates in this subcolumn are applicable at accession, subcolumn (2) means that the duty rates in this column are applicable six years after accession.
5. Duty rates indicated by (*) in column 3 are applicable one year after accession.
6. Duty rates attached to four or six digit tariff numbers apply to all other products which fall within the described product categories, unless otherwise specified at six, seven or eight digit level.
