**SCHEDULE CLIII - THE SEPARATE CUSTOMS TERRITORY OF TAIWAN,
PENGHU, KINMEN AND MATSU**

WHEREAS the CONTRACTING PARTIES to the General Agreement on Tariffs and Trade 1947 adopted, on 26 March 1980, a Decision on Procedures for Modification and Rectification of Schedules of Tariff Concessions (BISD 27S/25);

WHEREAS in accordance with the provisions of the above-mentioned Decision, a draft containing modifications and rectifications to Schedule **CLIII - The Separate Customs Territory of Taiwan, Penghu, Kinmen and Matsu** was communicated to all Members of the World Trade Organization in document G/MA/TAR/RS/143 on 17 June 2008;

IT IS HEREBY CERTIFIED that the modifications and rectifications to Schedule **CLIII - The Separate Customs Territory of Taiwan, Penghu, Kinmen and Matsu** are established in conformity with the above-mentioned Decision.

The annexed modifications and rectifications are effective as of **17 September 2008**

This Certification is deposited with the Director-General of the World Trade Organization, who shall promptly furnish a certified true copy to each Member of the World Trade Organization. It shall be registered in accordance with the provisions of Article 102 of the Charter of the United Nations.

**SCHEDULE CLIII - THE SEPARATE CUSTOMS TERRITORY
OF TAIWAN, PENGHU, KINMEN AND MATSU**

17 September 2008

This rectification relates to the description of HS tariff item 1904.90.10 on page 6 under Section I-A Tariffs of the authentic text of the certification of modifications and rectifications to Schedule CLIII - the Separate Customs Territory of Taiwan, Penghu, Kinmen and Matsu which was circulated in document WT/Let/578, a certified copy of which was furnished to all Members on 4 July 2007. The description of HS tariff item 1904.90.10, which should read "Cereals (other than maize (corn)) in grain form, or in the form of flakes or other worked grains (except flour and meal), precooked or otherwise prepared, not elsewhere specified or included, containing not less than 30% of rice", inadvertently omitted the last four words. Therefore, the missing words ("than 30% of rice") should be added at the end of the relevant description in the certification. This rectification does not alter the concessions and commitments of the Separate Customs Territory of Taiwan, Penghu, Kinmen and Matsu under Schedule CLIII.
